The education system in Azerbaijan is composed of the following levels of educational institutions: pre-school, elementary school, secondary school, vocational school such as technical, medical, pedagogical and other specialized colleges, higher colleges, universities, and the Academy of Science.

School education starts at the age of 6 and lasts for 11 years. 9 years of school education is compulsory. After successful completion of the 9-year school education, individuals may either continue their education in high schools or go to 2- or 3-year specialized vocational schools. Those who successfully complete a vocational school receive a junior specialist degree, which is similar to the American associate degree.

Graduates who have completed 11-year school education or 9-year school education plus a vocational school have the right to take the Student Admission Test managed by State Student Admission Commission to enter higher education institutions. Those who receive the required grades/points in the Student Admission Test get admitted to an undergraduate program in their chosen university.

Higher education in Azerbaijan is composed of 3 or 4 levels, depending on which model of education the institution applies.

Khazar University is the only university in Azerbaijan that applies the 3-level higher education model of study – undergraduate (Bachelors degree – 4 years of study), graduate (Masters or professional degrees – 1,5 or 2 years of study in addition to undergraduate program) and doctorate (PhD – 3 or more years).

All other universities in Azerbaijan, except Khazar University, apply a mixture of old Soviet and Western education models. This model of higher education consists of four levels – undergraduate (Bachelors degree), graduate (Masters degree), Aspirantura (Candidate of Science degree) and doctorate (Doctor of Science degree – no time limit).

There are 33 public and 14 private higher educational institutions in Azerbaijan, offering various undergraduate, graduate and doctoral degrees. Both private and public higher education institutions are accredited by the Council of Ministers and/or the Ministry of Education of the Republic of Azerbaijan.
